


Hubman picks champ

Angus breeders gathered in Louisville, Ky., to compete for top honors at the 2000 North American International Livestock Exposition (NAILE) Roll of Victory (ROV) Super Point Angus Show. Dick Hubman, Central Point, Ore., selected the champions from 337 entries, which included 258 females and 79 bulls.

Koupal's B&B Rainmaker 9020 claimed the grand champion bull title after first winning the junior division. Roth Angus, Freeman, S.D.; Koupal's Angus Ranch and Vern Koupal, both of Dante, S.D., own the Jan. 1999 son of Sitz SLS Rainmaker 7596.

WK Gunsmoke, a February 1998 son of OGL Battlecry 427 128, captured reserve grand champion bull honors. Whitestone-Krebs and The Gunsmoke Gang, both of Gordon, Neb., own the bull that first topped the senior division.

In the female show, Green's Savannah 9909 claimed the grand champion and junior champion awards. Savannah Green, Volborg, Mont.; and Joseph Malson, Parma, Idaho, own the April 1999 daughter of OGL Battlecry 427 128.

Champion Hill Peg 1580 won reserve grand champion female. The April 1999 daughter of Leachman Saugahatchee 3000C first won reserve junior champion female. Champion Hill, Bidwell, Ohio; and John Nicolai, Barboursville, Va., own the victorious female.

Famous 7001 sired the winning junior get-of-sire, which was exhibited by Roth Angus, Freeman, S.D.; Advance Cattle Co., Nashport, Ohio; and Beth Patton, Crawfordsville, Ind. Champion Hill, Bidwell, Ohio, claimed both the winning get-of-sire by Leachman Saugahatchee 3000C and the best six head.







Board of Directors Meeting - Nov. 11, 2000

Board Meeting Highlights

The following is a review of action taken during the meeting of the Board of Directors on Nov. 11, 2000.

Pursuant to notice, the meeting of the American Angus Association Board of Directors was called to order in the King Room of the Executive West Hotel in Louisville, Ky., by President Bud Smith. The following officers and directors were present: Bud Smith, president; Howard Hillman, vice president; Leroy Baldwin, treasurer; Keith Arntzen, Leo Baker, Henry Bergfeld, Jim Bradford, Minnie Lou Bradley, Steve Brooks, John Curtin, Joe Elliott, Ben Eggers, Jot Hartley, Brian McCulloh, Cecil McCurry, Lowell Minert and Abbie Nelson

Director of Finance Richard Wilson presented the 2000 year-end audited financial report, which was reviewed in detail by the Board.

Wilson also reviewed the October 2000 financial reports for the Board.

Initial guidelines for handling cell-cloned transplants were distributed to Board



members to study and to discuss at the February Board Meeting.

Joe Elliott, chairman of the task force to study the feasibility of a *Certified Angus Beef*[™] Marketing Cooperative, gave a report of the task force's Nov. 2, 2000, meeting. The task force recommended that the issue continue to be studied. The Board agreed that further meetings should be conducted. The task force was scheduled to meet next in December 2000.
