Board meets at Annual Convention

The following is a review of the topics discussed and actions taken during the Nov. 3 and 6, 2017, meetings of the American Angus Association Board of Directors in Fort Worth, Texas.

Topics addressed

- Julie Murnin, 2017 president of the American Angus Auxiliary, provided an overview of the Auxiliary's activities of the past year.
- The 2017 annual audit reports of the financial statements of the American Angus Association and the Angus Foundation (Foundation) were presented to the Board.
- Jonathan Perry moved, seconded by James Coffey, to amend the draft of the Association Sept. 11-13, 2017, regular Board meeting minutes to include this statement: "This budget does not include any cash outlay that may be needed to implement strategies within the Long Range Strategic Plan (LRSP)." The motion was unanimously approved.
- John Grimes moved, seconded by Alan Miller, to approve the minutes of the Sept. 11-13, 2017, regular Board meeting as amended. The motion was unanimously approved.
- Jonathan Perry moved, seconded by James Henderson, to name the boardroom at the Association headquarters after Richard E. Wilson, recently retired CFO, in honor of his 48 years of dedicated

and exemplary service. The motion was unanimously approved. The announcement of the "Richard E. Wilson Boardroom" was to be made at the opening session of the Angus Convention, and a plaque was to be presented to Wilson.

- The Board considered a request by Association member and delegate Andrew Stewart to change wording of the "Procedures to Govern the Election of Five Members to the Board of Directors of the American Angus Association" to more clearly state how the majority vote is determined. The procedures had been approved by the Association Board of Directors at the September regular Board meeting. James Coffey moved, seconded by Barry Pollard, to change the wording of the procedures as proposed. The motion was unanimously approved. The change in the procedure was to be explained to the delegates on Monday prior to any electronic voting during the Annual Convention of Delegates.
- The Board considered correspondence received from Association member and delegate Duane Morley Cox regarding

questions about recent changes in calculating birth weight (BW) expected progeny differences (EPDs). Staff presented information related to the questions posed in the letter. No action was taken. Dan Moser, president of Angus Genetics Inc. (AGI), was to contact Cox to discuss his concerns.

- Moser presented additional information to the Board regarding BW and weaning weight (WW) EPDs. Examples of changes in WW EPDs when birth weight data is added were presented. Change in growth trait EPDs resulting from birth weight data submission is minimal.
- As previously requested by the Board, Stephen Miller, director of genetic research, presented the top five potential research topics that have been identified by staff. Following thorough discussion, Don Schiefelbein moved, seconded by David Dal Porto, that staff develop a proposal for an internship program for data collection on foot structure by Jan. 1, 2018. The motion was unanimously approved.
- Following additional discussion

on foot structure, Barry Pollard moved, seconded by Richard Dyar, to direct staff to bring to the Board a refined disposal code system, which includes a better definition of foot structure. The motion was unanimously approved.

- The Board next discussed the current dollar value (\$Value) indexes. Jerry Connealy moved, seconded by Dave Nichols, to direct staff to move ahead with improving the current \$Value indexes and to bring cost considerations to the Board before the February regular Board Meeting. This does not include development of a total index. Motion passed by a vote of 14 in favor and two opposed.
- At the request of Director Jerry Connealy, the Board discussed whole-herd reporting. Staff was directed to gather information on the subject, which will be included as an agenda item at the February 2018 Board of Directors regular meeting.
- Discussion occurred regarding the proposed building expansion. Staff presented various options explored during the past two months and noted that the project has been deemphasized moving forward due to other higher priorities within the LRSP.
- Staff reported on Angus Convention statistics, including more than 2,300 registrations and 474 exhibitors. Main events of the convention schedule were reviewed. A session has been added on Saturday afternoon for members and attendees to meet with Board and staff in a casual setting. The session will be announced at the Angus Convention opening session on Saturday morning.
- The Board reviewed

correspondence received from Association member Nick Nesson. Confidentiality matters and fiduciary responsibilities of Board members were discussed. The Board also discussed Board policies concerning reporting and release of minutes of Board meetings, as well as current fees for services. The Board will include a discussion of transparency on the agenda of the February regular Board meeting.

- Don Schiefelbein moved, seconded by Jerry Connealy, to approve the proposed budget of the LRSP Feeder Calf Program. The motion was unanimously approved.
- Pursuant to the Association's bylaws, James Coffey moved, seconded by Jonathan Perry, to elect Allen Moczygemba as CEO and Kenny Miller as assistant secretary for 2018. The motion was unanimously approved.
- The 2018 Annual Convention of Delegates will be convened Nov. 5, 2018, in Columbus, Ohio.
- James Coffey moved, seconded by James Henderson, to approve the 2017-2018 meeting dates as proposed. The motion was unanimously approved.

Angus Foundation

- Dave Nichols moved, seconded by James Coffey, to elect the Board of Directors of the Angus Foundation for 2018 as proposed. The motion passed unanimously. Lamar Steiger was previously elected in September 2017 to serve a one-year term as outside representative, effective Nov. 6, 2017.
- Dave Hinman nominated James Coffey to serve as chairman of the Foundation Board for 2018. The nomination was seconded by Richard Dyar. The nomination was approved unanimously.
- Barry Pollard moved, seconded by Alan Miller, to elect additional officers for 2018 as shown below. The motion passed unanimously.
