- Members presenting at the Board meeting may attend the member presentation portion of the meeting. Attendance beyond the member presentation portion of the meeting will be at

the discretion of the Chairman. A policy was established, as shown below, for the publication of Association Board meeting agenda highlights.

- Primary, non-confidential discussion and anticipated action items will be publicized on the Association website at least 72 hours before regularly scheduled Board meetings (September, November, February and June).
- Items to include on the published agenda highlights will be at the discretion of the Chairman and CEO.
