# New Association Committees, Agenda Set for 1994

The meeting of the Board of Directors was called to order in the William Room of the Executive West Hotel, Louisville, Ky., Saturday, Nov.13,1993 by president Keith Stevenson. The following officers and directors were in attendance:

#### MEMBER DISCIPLINARY HEARING

President Stevenson, pursuant to Article VII of the By-Laws of the American Angus Association, called a due process, disciplinary hearing to order regarding possible misrepresentation and/or misconduct by Joe Farrar, Thomas Coop and Jeremy Coop in connection with the registration and exhibition of TC Sensation, #11733450, under the known alias of JC Queen Dolly,#11798705. Joe Farrar, Thomas Coop and Jeremy Coop were present for the hearing.

Testimony was given by Joe Farrar, Thomas Coop and Jeremy Coop relative to these charges. Donald R. Painter, director of member services for the American Angus Association, also testified at this hearing.

After consideration of all the evidence, including all the exhibits offered by the Association and the respondents, testimony of Donald R. Painter, Joe Farrar, Thomas Coop and Jeremy Coop, and after a properly noticed and open due process hearing, the Board of Directors

reached the following decisions:

First, Joe Farrar is found guilty of the misconduct charge in connection with the registration and ultimate exhibition of TC Sensation under the known alias of JC Queen Dolly at the 1993 Tennessee Junior Exposition.

The penalty for this misconduct is to suspend for five years from this date Joseph Farrar's membership in this Association and all privileges of that membership including but not limited to the registration and transfer of cattle and the exhibition of cattle at any fair, association, livestock show or exposition to which funds are appropriated by the Association for payment of premiums in accordance with the provisions of Article VII of the By-Laws of this Association.

Second, Thomas Coop is found guilty of the misconduct charged in connection with the registering and exhibition of TC Sensation under the known alias of JC Queen Dolly at the 1993 Tennessee Junior Exposition.

The penalty for this misconduct is to suspend for three years from this date Thomas Coop's membership in this Association and all privileges of that membership including but not limited to the registration and transfer of cattle and the exhibition of cattle at any fair, association, livestock show or exposition to which funds are appropriated by the Association for payment of premiums in accordance with the provision of Article VII of the By-Laws of this Association.

Third, Jeremy Coop is found guilty of the misconduct charged in connection with the exhibition of TC Sensation under the known alias of JC Queen Dolly at the 1993 Tennessee Junior Exposition.

The penalty for this misconduct is to suspend for one year from this date Jeremy Coop's membership in this Association and all privileges of that membership including but not limited to the registration and transfer of cattle and the exhibition of cattle at any fair, association, livestock show or exposition to which funds are appropriated by the Association for payment of premiums in accordance with the provisions of Article VII of the By-Laws of this Association.

Brian Swartz moved and Glen Swanson seconded the motion to adjourn the meeting. Meeting adjourned at 7:03 p.m.

Board of Directors Regular Session

At 8:43 p.m. on Saturday, Nov. 13, 1993 the Full Board of Directors meeting reconvened, in regular session, with all parties that were present earlier on this date. In addition, also present were Richard Wilson, John Crouch and Bob Chern from the Association staff and Terry Cotton from the *Angus Journal*.

President Stevenson requested the approval of the minutes of the Sept. 12-13, 1993 Board meetings. There being no additions or corrections, Stan Watts moved and Ralph Bridges seconded the motion they be approved. Motion carried unanimously

Director of finance Richard Wilson presented the 1993 yearend financial audited report which was reviewed, in detail, by the Full Board.

Wilson reviewed the October 1993 financial reports, as submitted, for the Full Board.

The next item on the agenda was an update on the Angus Herd Management Software Program. Executive vice president Richard Spader reported on the Oct. 15, 1993 conference call of eight selected users of the AHM Windows™ Software program as well as the meeting held at the Association office on Nov. 2-3, 1993 with five of the users of the program. A lengthy discussion was held by the Full Board.

After discussion, a committee consisting of Tom Perrier, Bill Borror, Lawrason Sayre and chaired by Paul Meier was appointed to monitor the development of this program.

The next subject discussed was a report on the new format for the Sire Evaluation Report. The new format, which will provide for all EPDs pertaining to one bull to appear on one line, was discussed. It was the general consensus that this would greatly improve the readability of the report.

Brian Swartz, chairman of the activities committee, reported that Dick Hubman, Central Point, Ore.; Don Boggs, Brookings, S.D.; and Dick Burns, Dunlap, Ill.; will comprise the three-man judging team for the 1994 Western National Angus Futurity in Reno, Nev.

Executive vice president Spader stated that Van Dyke Angus Ranch has donated the pick of their heifer calf crop as the

Foundation Heifer for the Junior Angus Foundation to be auctioned during the 1994 National Western Stock Show in Denver. Spader requested the Board's help in locating bidders interested in purchasing this heifer package.

Spader reported that a staff and regional manager meeting, which will include Association, Certified Angus Beef Program and *Angus Journal* personnel, will be held Feb. 2-3,1994 in St. Joseph, Ma

He also reported that LytleTom had contacted him relative to the Association presenting a program in conjunction with the Short Course being held at Texas A&M during August 1994. This program is already in the planning stages by staff members.

Spader recommended that a Supply Development Summit be held on March 18, 1994 in conjunction with the quarterly Board of Directors meeting in St. Joseph, Mo. It was stated this was the most feasible time to hold this meeting.

Next, Spader said that the Association will soon register the 12,000,000 animal since the Association was founded in 1883. He stated that this subject had been discussed by the executive commit-

tee and it has been determined that to commemorate the event, registration number 12,000,000 will be auctioned at the 1994 National Western Stock Show with the proceeds to the National Junior Angus Foundation.

There being no further business to come before the Board, T.D. Steele moved and Brian Swartz seconded the motion to adjourn. Meeting adjourned at 10:50 p.m.
