Da-Es-Ro Angus Farms named historic herd

Da-Es-Ro Angus Farms, Columbus Junction, Iowa, has been recognized as a Historic Angus Herd by the American Angus Association. The farm is owned and managed by the **Robert Schlutz family**.

Robert Schlutz purchased his first Angus heifer in 1948 as a 4-H project. The herd continued to grow until he graduated from high school. Upon graduation, Robert and his parents, Dale and Esther Schlutz, formed a partnership known as D.E. Schlutz & Son. The growing herd was later named "Da-Es-Ro," which was comprised of the first two letters of the partners' names.

Four generations have taken active roles in the operation during its more than 50 years in the Angus business. Robert is still very active in the management of the herd, which includes 120 head of cows. He is assisted by his grandson, Eric Schlutz.

Da-Es-Ro hosts an annual production sale in December. The Schlutzes use ultrasound, artificial insemination (AI) and embryo transfer (ET) to improve genetics. The herd is enrolled in the Association's Angus Herd Improvement Records (AHIR) program as well.

On Dec. 15, 2001, **Burke Healey**, Davis, Okla., and **Don Ramsey**, Jones, Okla., were honored with the Distinguished Agriculture Alumnus award from Oklahoma State University (OSU). A 1955 graduate in animal science, Healey has served on the NCBA Board of Directors for the past six years, representing the American Hereford Association and Oklahoma producers as a whole. Additionally, he has served on the National Cattlemen's

Association executive committee and as president of the Beef Improvement Federation (BIF) and the Oklahoma Cattlemen's Association.

Sieben Livestock, led by Chase Hibbard, is one of the oldest ranches in Montana. It has been in existence since 1907. Since that time, the operation has seen significant changes that have improved range conditions and forage quality, which have resulted in positive effects on the ranch's overall productivity.

Sieben Livestock will advance to regional competition through the National Cattlemen's Beef Association (NCBA). They will compete with nominees from Washington, Oregon, Idaho, Wyoming and Colorado.

IN PASSING

Frank Harding, 90, of Vermont, died Jan. 12. He was the chairman and founder of American Live Stock Insurance Co.

Harding was born at Anoka Farms in Waukesha, Wis. He attended the University of Chicago where he received a bachelor's degree in philosophy.

He served as a lieutenant commander on a destroyer in the Pacific Ocean during World War II (WWII). After the war, Harding lived in Chicago, but moved to Geneva, Ill., in 1950. He was active in many business and social organizations with particular involvement in the Geneva Golf Club where he served as president, the local hospital where he served as trustee, and Dunham Woods Riding Club in Wayne, Ill.

After WWII, Harding teamed up with his father and formed Harding & Harding, which at the time was an insurance agency as well as an importer and exporter. In 1952 Harding and lifelong friend Clint Tomson founded American Live Stock Insurance Co.

Frank was preceded in death by his wife, Mary Jo, as well as his son, Terry, and daughter, Dana. He is survived by his daughter, Kris, and partner, Jean Adams.

His livestock career started with the husbandry and showing of Shorthorn cattle. Later, he worked at major ranches in the West.

He was a head cattle buyer for Armour & Co. in Oklahoma City, Okla. He was also a livestock judge as well as an exporter and importer of cattle. He originated the third-country concept for bringing cattle to America. He worked to protect the health and welfare of the industry from disease, and he was honored as a life member of the U.S. Animal Health Association.

Harding is the only third-generation inductee to the Saddle & Sirloin Club. He was honored in 1982. His father and grandfather received the honor in 1915 and 1905, respectively.
