## Membership engagement

The 139th Annual Convention of Delegates will take place in conjunction with the Angus Convention in Salt Lake City, Utah, Nov. 5-7, 2022. Why is the director of member services writing about an event that will take place months from now and registration doesn't open until July 1, 2022?

#### Voting eligibility

Realizing that November is a long way from today, time moves quickly, and travel takes more planning in today's world. More importantly, the deadline to fulfill eligible voting member requirements for this year's convention is April 8, 2022, which is right around the corner (for more on eligibility, see "Membership Tips," in the March 2021 Angus Journal). You can check your eligibility status within your AAA Login account by clicking on My Account > My AAA Information. Keep in mind your eligibility box will become unchecked if your dues expire between now and April 8.

# From participation to relationships

Association participation is a great way to grow, connect, learn, be inspired and unite. Membership engagement and participation in Association events is the fuel for networking that takes place within our industry. The American Angus Association is no exception. While it takes intentionality to get off the ground in building a network of colleagues and mentors, the

investment is well worth it. Isolation is a difficult place to thrive.

#### 25,000 members

It is true, the Association is blessed to have a vast, diverse membership representing all sizes and types of operations. However, at the 2021 Convention of Delegates, there were unfortunately several empty seats among the delegation. Was this related to personal health issues? Most likely. The Angus Convention can be your path for Association involvement.

#### Membership connection

Delegate nomination procedures are set forth in the Bylaws of the American Angus Association in Article III Convention of Delegates, Section 3.7 Nomination of Delegates. The Bylaws can be found in the Breeder's Reference Guide in the "Rules and Forms" section.

### Considerations

- An Eligible Voting Member can nominate him/herself.
- Each Eligible Voting Membership can make only one nomination.
- Only one individual from each Eligible Voting Membership can be placed on the ballot.
- It is best to nominate an Eligible Voting Member who, if elected, will attend the Annual Convention of Delegates.
- Names are placed on the ballot in order of date received.
- After the nomination period ends, ballots are prepared and mailed to life and regular members that have qualified as Eligible Voting Members.
