Online nominations

The 135th Annual Convention of Delegates takes place Monday, Nov. 5, 2018, during the national Angus Convention in Columbus, Ohio. As a member of the nation's largest beef breed organization, you play an important role in the business of the Angus breed and electing the leaders of the American Angus Association.

According to Association bylaws, only eligible voting members can nominate, be nominated, vote or be elected in the annual election of delegates. In order to participate in the electoral process for the 135th Annual Convention of Delegates, a member must be considered an eligible voting member and must have met all of the following

requirements by 4:30 p.m. CDT April 6:

- Active regular or life membership (dues paid in full)
- 18 years of age or older
- Registered at least one animal or conducted a threshold dollar amount of business (excluding membership fees) with the Association or Angus Genetics Inc. within the preceding 12 months from when

the nomination period begins (from April 10, 2017, to April 6, 2018).

Considerations

- An eligible voting member can nominate him or herself.
- Each eligible voting membership can make only one nomination.
- Only one individual from each eligible voting membership can be placed on the ballot.
- It is best to nominate an eligible voting member who, if elected, will attend the Annual Convention.
- Names are placed on the ballot in order of date received.
- After the nomination period
