■ IN PASSING

George Martin Wheeler, 86, died Jan. 31 in Charlotte, N.C.

He was born in Indianapolis, Ind., on Sept. 28, 1914. He was the son of George O. and Angeline (Donahue) Wheeler. After his mother's death in 1916, he and his sister lived with his aunt Beatrice (Wheeler) Peats and her husband, Roy, until he was 14. Because of asthma and health reasons, he then moved to Rogersville, Tenn., to live with his aunt Margaret (Wheeler) Orr and her husband, Joseph. It was on their farm that Wheeler began his life as a purebred cattle breeder.

Wheeler attended Duke University after graduation from Rogersville High School. During World War II, he served in the U.S. Navy.

Active in the development of Angus cattle for many years, he kept his own farm, Hickory Cove, in Rogersville, while serving as manager of Allandale Farm, owned by Harvey Brooks in Kingsport, Tenn. He continued as manager of Allandale when Kingsport businessman E. Ward King leased the operation.

Wheeler was a former president of the East Tennessee and Tennessee Angus associations and a director of the Southeastern Angus Association. He was also a life member of the American Angus Association.

The University of Tennessee Block and Bridle Club chose him as the Man of the Year in Animal Husbandry in 1963.

He was a former Sunday school teacher, deacon, elder and clerk of session in the Presbyterian Church.

He was preceded in death by a sister, Margaret Wheeler, in 1993. He is survived by his wife of 63 years, Ruth; a daughter, Margaret Cathcart; three grandchildren; and three great-grandsons.

John C. Hoyt, 78, Great Falls, Mont., passed away March 26 at the Benefits Hospital in Great Falls during a heart catheterization procedure.

Hoyt was born June 28, 1922, in Shelby, Mont. Hoyt's parents had come to Shelby from Iowa, and the family's background was in farming and ranching. Hoyt's father, a lawyer, raised his family in Shelby during the Great Depression. Hoyt, however, spent summers in Iowa during the hard times.

He began his college career at Drake University, Des Moines, Iowa. After a time, he returned to Montana, where he enrolled at the University of Montana at Missoula.

World War II broke out while Hoyt was an undergraduate. He joined the Army Air Corps the day after the bombing of Pearl Harbor and became a navigator on a B-24 as a second lieutenant. In August 1944, his plane, the Jolly Roger, was shot down by German fighters. Hoyt was captured and spent most of a year as a prisoner of war.

After the war, Hoyt graduated from the University of Montana Law School in 1948 and began his 53-year career in law. At the time of his death, his firm, Hoyt and Blewett, was prominent in Montana.

Hoyt had a lifelong passion for agriculture and established Jolly Roger Angus Ranch, named in honor of his wartime comrades.

Hoyt was a member of the Cascade County Bar Association, the Montana Bar Association, and the Montana and American trial lawyers associations. He was a member of the American College of Trial Lawyers, the International Academy of Trial Lawyers and the Inner Circle of Advocates. He was awarded a Lifetime Achievement Citation by the Montana Trial Lawyers in recognition of his 50 years of distinguished trial practice in Montana.

He also was active in the Montana and American Angus associations.

His survivors include his wife, Vickie; a son, John R. of Washington state; a daughter, Mary Lou Sandretto of Georgia; a sister, Lois Matsler of Bloomington, Ill.; and three grandchildren.

The family suggests memorials in Hoyt's name to the charity of one's choice.

Walter Harrell, 73, Haynesville, Ala., passed away on March 5. He was a lifetime Angus breeder and enthusiast.

In 1947 he established Harrell Angus Farm, a herd recognized as a Historic Angus herd by the American Angus Association in 1983.
