

# Delegates Selected

*Elections will be hosted at the Angus Convention Nov. 8 in Fort Worth, Texas.*

Last spring a form on which to nominate delegates to the 138th Annual Convention of Delegates was sent to active life or regular members of the American Angus Association who qualified as eligible voting members by April 9, 2021. Nominees could be any eligible voting member

whose farm or ranch is located in the same state as the original nominator.

After the completed forms were returned to the Association office in Saint Joseph, Mo., ballots were prepared and sent to eligible voting members in each voting district. Properly executed ballots returned

to the Association by the Aug. 10 deadline were counted.
