**B3R Country Meats,** Childress, Texas, won the Texas Cattle Feeders Association (TCFA) Beef Merchandiser Award for 2002. The award, presented by the TCFA during its 35th convention in Amarillo, recognizes companies that set the pace in innovative ways to sell beef.

Minnie Lou Bradley and daughter Mary Lou Bradley began the company in 1986. It was the first all-branded beef product to be marketed across the country and to reward ranchers with a value-based marketing system.

For their involvement in agriculture, **John** and **Jean Riffle**, Pleasant Hill, Mo., received the Missouri Farm Family award at the American Royal in Kansas City, Mo. The Missouri Department of Agriculture presented the award.

The Kansas City, Kan., Women's Chamber of Commerce also honored the Riffles at a luncheon at the Agriculture Hall of Fame.
