Judge Kelly Bruns, Brookings, S.D., evaluated 136 entries at the 1999 Nebraska State Fair.

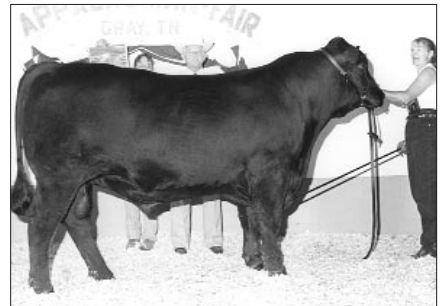

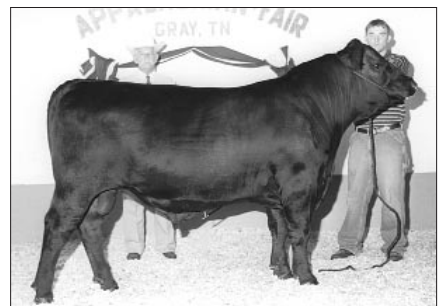

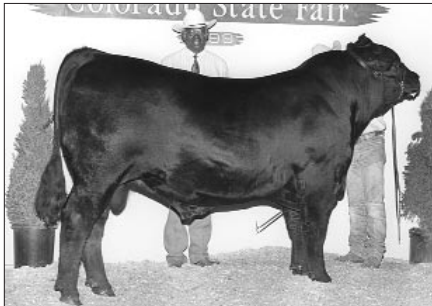

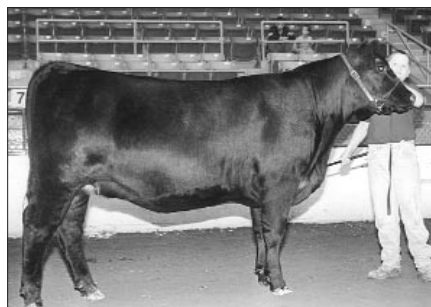

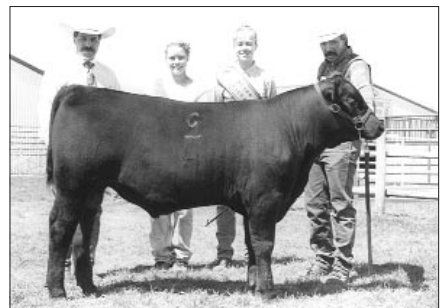

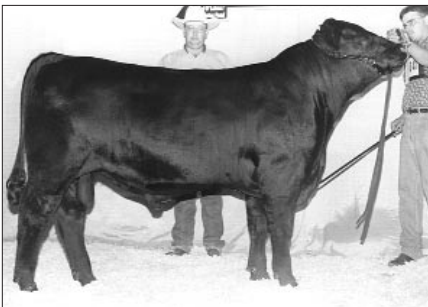
