president of the American Angus Association, I am filled with humility. I am also filled with respect and admiration for our officers, directors and staff for rising to the occasion and providing a sense of security and comfort for Association employees and members alike. Like the people of New York City, we were shaken, but not removed from the task at hand — service to our members. This member service is continuing in an uninterrupted fashion.
