Wilson Cattle Co., Cloverdale, Ind., and Ryan Long, Blue Mound, Ill., showed the grand

champion bull, KF Precision 361. The January 2001 son of Twin Valley Precision E161 first won junior champion honors.

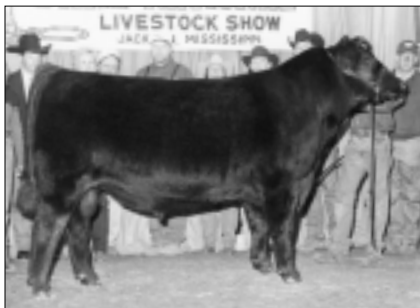
