**Renamed vaccines**

Boehringer Ingelheim Vetmedica Inc. has announced that its Breed-Back® FP reproductive vaccines family will be renamed Express® FP. The vaccines are designed to prevent calves persistently infected (PI) with bovine viral diarrhea (BVD) from entering and reinfesting the herd.



The vaccine line has just received U.S. Department of Agriculture (USDA) Animal Plant Health and Inspection Service (APHIS) approval for use in whole-herd vaccination programs. According to a company release, the new whole-herd licensing approval ensures producers that the vaccine is considered safe to use in

calves nursing pregnant cows, as well as in gestating cows at any stage of pregnancy, as long as those cows have been previously vaccinated before pregnancy with the vaccines.

**Vaccine approval**

Pfizer Animal Health announces that Draxxin® (tulathromycin)

Injectable Solution is now approved for the treatment of infectious bovine keratoconjunctivitis, commonly known as pinkeye. The Food and Drug Administration (FDA) approved the claim after reviewing research that showed a single dose of the vaccine was effective against pinkeye associated with *Moraxella bovis*.

According to the release, the vaccine is also the only antibiotic approved for the treatment and control of bovine respiratory disease (BRD) associated with all four major BRD bacterial pathogens — *Mannheimia haemolytica*, *Pasteurella multocida*, *Histophilus somni* and *Mycoplasma bovis* — in cattle at high risk of developing the disease.
