WCC Extra Stout N7 claimed grand champion and junior champion bull honors. Wilson Cattle Co., Cloverdale, Ind., led the January 2003 son of TC Extra 9140.

CQS Bando Connection 5042 captured reserve grand champion bull for Callie Smith, Lebanon, Tenn., and DAB Angus, Bell Buckle,

Tenn. The November 2002 son of BT Bando 196J first won senior champion.

WCC Blackcap N9 won grand champion female. Wilson Cattle Co. and Express Angus Ranches, Shawnee, Okla., own the January 2003 daughter of WCC Special Design L309 that first topped the junior division.

Jeana Sankey, Council Grove, Kan., led the reserve grand champion female. CS Valee's Liberty 305 is a March 2003 daughter of TC Freedom 104 and first won reserve junior champion.

WAF Missie 3137 captured grand champion female. Weaver Angus Farm, Peoria, Ill., owns the September 2003 daughter of CA Future Direction 5321 that first won senior calf champion.

Dameron Northern Miss 3114 won reserve grand champion
