Exhibitors Compete in American Royal Angus Show

Exhibitors from 22 states vied for top honors in the 2010 American Royal Super-Point Roll of Victory (ROV) Angus Show, judged by Mike McGuire of Waverly, Ala., Oct. 30.

The grand champion bull was EXAR Velocity 81213, exhibited by Express Angus Ranches, Yukon, Okla.; Brad & Dawn Gohr, Madras, Ore.; and Rockin' A&J Ranch of Auburn, Wash. The March 2008 son of EXAR Lutton 1831 was first selected as senior champion.

The reserve grand champion bull, DAJS Shockwave 612, was exhibited by Jennifer Ewing and Matthew Ewing, both of Rushville, Ill.; and Katy Satree, Montague, Texas. The May 2009 son of Gamble's Hot

Rod was the champion intermediate bull.

Grand champion female honors went to McCurry Blackcap 9024, sired by Marand's M-W Assassin 518, and exhibited by Tanner Rayl, Hutchinson, Kan. Rayl's March 2009 female was first named junior champion.

The reserve grand champion female, as well as the reserve junior champion, was Champion Hill Georgina 72561. The March 2009 SAV Bismarck 5682 daughter was shown by Mandy Richardson of Louisa, Va.

The champion cow-calf pair featured Champion Hill Georgina 6518, a January 2008 daughter of SAV Bismarck 5682. She had a February 2010 daughter of SAV Pioneer 7301 at side. The pair was shown by Thomas Lundy, Bardstown, Ky.

The reserve champion cow-calf pair was CQS Lady Betty 3207, an SAV Prairie Knight 5666 daughter. Exhibited by Callie Smith of Lebanon, Tenn., she had a May 2010 son of CQS New Day EXT 1177 at side.

The American Royal, Kansas City's longest-running show, has been a Kansas City tradition since 1899. During September, October and November, more than 250,000 people attend the American Royal.
