# The importance of unrestricted gifts

The Angus Foundation has benefited greatly from generous supporters for more than 36 years. Innovative and important educational programs for you, our members, as well our affiliates, have come about because of generous financial support from individuals, allied industry interests and friends.

# **Progress**

Cutting-edge and timely research funded by the Angus Foundation will help make progressive strides in our continued quest for improvement of the Angus breed and the value received by users of Angus genetics.

Increased levels of scholarship support and expanded leadership training supporting Angus youth have been realized from your financial support. The benefits of these educational investments will provide long-term benefits to our breed. Your commitment to grow these programs is critical to our mission and will likewise require additional focus and investment with unrestricted funds.

Significant growth of the Angus Foundation's asset base has raised the need for increased understanding about the composition, uses and availability of these funds, and understandably so, as the Angus Foundation's net assets totaled \$19.2 million at fiscal year-end Sept. 30, 2016, representing 37% of the American Angus Association's consolidated assets of \$52.3 million.

Before going further, it's important to remember why the American Angus Association created the Angus Foundation.

### **Origins**

Angus breeders, as with all agricultural producers across rural America, are compassionate and giving people. Whether

it's helping a neighboring farmer or rancher work cattle, harvest crops or, yes, giving charitably of our hard-earned financial resources, the desire to help others is entrenched in all of us. That's the way we were raised on the farm, always willing to lend a helping hand.

More specifically, the desires to help our Angus youth, along with other Angus breeders and commercial producers through support of education and beef cattle research, were found to be long-time shared goals of Angus breeders.

A formal platform was needed within the American Angus Association's structure, and in 1980, the Angus Foundation was established under section 501(c)(3) of the Internal Revenue Code. This recognition provides the organization benefits of being exempted from federal income tax, as well as eligibility to receive tax-deductible charitable contributions to the extent allowed by law.

Several requirements must be met for a charitable organization to obtain 501(c)(3) status, including being organized as a corporation, trust or unincorporated association. The organization's organizing

document, the Angus Foundation's *Articles of Incorporation*, limit its purposes to being charitable and permanently dedicate its assets to charitable purposes. Most tax-exempt organizations are required to file annual financial reports at the state and federal levels, and make these forms publicly available.

Composition of the Angus Foundation's asset portfolio includes endowed and non-endowed funds (see Fig. 1).

Endowed funds (endowments) are established for the purpose of permanently carrying the name and legacy of the donor(s), their Angus farm or ranch, beloved family member, friend, etc., in perpetuity.

From a mechanics standpoint, only the investment earnings determined by the organization's board-approved spending policy are available annually from the endowment for expenditure toward the use (e.g., awards, scholarships, education, research, etc.) agreed upon between the Angus Foundation and donor when the charitable gift was made.

A complete list of the wide array of existing endowments and non-endowed funds currently administered and managed by the Angus Foundation can be found in the sidebar to this column.

One appealing feature of an endowment is that donors can make additional gifts to the endowment at any time during their lifetimes. Another feature is donors who wish to include the Angus Foundation as a charitable beneficiary in their estate plans can designate their existing endowment to receive the funds.

# **Restricted and unrestricted**

Regardless of whether the net assets are

Fig. 1: Angus Foundation net assets Sept. 30, 2016 = \$19,244,118




Fig. 2: Angus Foundation net assets Sept. 30, 2016 = \$19,244,118





Fig. 3: Angus Foundation contributions during FY 2016\* = \$1,769,118

endowed or non-endowed, the funds are either restricted or unrestricted. Fig. 2 shows 74% permanently restricted and 21% temporarily restricted net assets at Sept. 30, 2016. Unrestricted gifts received by the Angus Foundation to be expended in the immediate future are temporarily held in a restricted account. These funds remain non-endowed so they can be available when needed for their subsequent expenditure.

In fiscal year (FY) 2016, as shown in Fig. 3,

of the charitable funds contributed to the Angus Foundation, donors restricted 67%.

All charitable gifts play crucial roles in our ability to carry out the Angus Foundation's mission of funding education, youth and research. As evidenced in the endowment list, numerous opportunities and benefits for our Angus youth, adult members and commercial producers have been made possible through gifts from our generous benefactors.

One example of the importance of both restricted and unrestricted funds in our organization's operations is the scholarships administered by the Angus Foundation, as evidenced in Fig. 4. General undergraduate and graduate scholarships are funded solely by unrestricted contributions and revenue

generated by fundraising activities such as the Angus Foundation heifer package, golf tournament, silent auction, annual fund and other fundraising activities. Donor named and other scholarships are funded by investment earnings from endowments that, as referenced earlier, were established with gifts restricted by the donor(s) for that purpose.

# **Maintaining programs**

Readily recognized existing education and youth programs such as Leaders Engaged in Angus Development (LEAD), Raising the Bar, the National Junior Angus Association (NJAA) Board of Directors, Cattlemen's Boot Camp, Women Connected Conference and

Beef Leaders Institute (BLI) historically have been funded in whole or in part from unrestricted gifts.

In closing, please know it's your Angus Foundation's continued wish to maintain current funding levels. However, our ability to do so will depend entirely on the availability of funds, either restricted or unrestricted.
