Supreme champion and grand champion bred-and-owned (B&O) female was **Vision Honey Bear 537**, a Feb. 2015 daughter of Vision Unanimous 1418 by Austin Vieselmeyer, Amherst, Colo. Reserve grand champion B&O female **KGM Elsa 5005**, a Jan. 2015 daughter of Silveira's Style 9303 by Kyra Meyer, Blue Hill.

Reserve supreme champion and grand champion owned female was **EXAR Blackbird 4894**, an Aug. 2014 daughter of Dameron First Impression by Kasey Meyer, Blue Hill. Reserve

grand champion owned female was **Lazy JB Ladymere Shiloh 530**, a Jan. 2015 daughter of KR O Canada by Shaila Bennett, Beemer.

Grand champion B&O bull was DAR Ali's Journey 571, a March 2015 son of SAV Brilliance 8077 by Aliesha Dethlefs, North Platte. Reserve grand champion B&O bull was NF Capitalist 028 by Davis Behle, Kearney. He's a March 2015 son of Connealy Capitalist 028.

Grand champion steer was TLF Classic 5, an April 2015 son of Dameron C-5 American Classic by Montana Lovett, Bladen. Reserve grand champion steer was AH PVA Red Zone

8141, a March 2015 son of SCC First-N-Goal GAF 114 by Austin Vieselmeyer.

OPEN SHOWS: 2015 Canadian Angus Gold Show Winners

The Canadian Angus Association announced the winners of the 2015 National Gold Show Program.

The 2015 black Angus Show Bull of the Year, receiving champion aggregate status, is **PM Thunderstruck 22'13** owned by Ryan Currie of Bristol, Que., Tanya Belsham of Houston, B.C., and Peter & Andy Vos of Plainfield, Ont. The reserve aggregate champion for black Angus Show Bull of the Year was awarded to **May-Way Breakout 1310** owned by Tanya Belsham and Caleb Flory of Baldwin City, Kan.

The 2015 black Angus Show Female of the Year, receiving champion aggregate status, is **BAR E L Erica 74A** and heifer calf Blairswest Miss Erica 400C at side owned by Maguire Blair of Drake, Sask. The reserve aggregate champion for black Angus Show Female of the Year went to **Remitall F Miss Queen 123B** owned by Remitall Farms Inc. of Olds, Alta.

The Canadian Angus Gold Show All-Star Team awards for black Angus bulls were awarded. Bull calf champion went to **Greenwood Colossal JJP 28C** owned by Jayden & Jaxon Payne of Lloydminster, Sask.; junior champion went to **Remitall F Boycott 71B** owned by

Remitall Farms Inc.; and senior champion went to **PM Thunderstruck 22'13** owned by Ryan Currie, Tanya Belsham, and Peter & Andy Vos.

Black Angus Female All-Star awards went to **Remitall F Karama 2C** owned by Remitall Farms Inc. as the heifer calf champion; **Remitall F Miss Queen 123B** owned by Remitall Farms Inc. as the junior champion; and **BAR E L Erica 74A** and heifer calf Blairswest Miss Erica 400C also owned by Maguire Blair as the senior champion.

The winners were recognized at Canadian Western Agribition in Regina, Sask., Friday, Nov. 27. The Gold Show program was developed in 1989 by the Canadian Angus Association to provide an incentive for breeders to move between regions to show cattle. Gold Show winners are determined by the animals that earned the highest number of points in three Gold Shows. If an animal accumulated points in more than three Gold Shows, the points from their best three shows were used in determining end-of-year awards.
