► The *Code of Federal Regulations* (CFR) is a compilation of the general and permanent rules published in the *Federal Register* by the executive agencies of the federal government. These regulations are organized by subject area and assigned to one of the 50 CFR Titles. Each Title is updated once each calendar year and can consist of as few as one printed volume or as many as 31.

The web site www.cfrs.com offers the complete line of CFR Titles, including Title 7 (agriculture), Title 9 (animals and animal products), Title 21 (food and drugs), Title 29 (Labor/OSHA) and Title 40 (environment).

CFRs are discounted 15% online every day, but may also be ordered at the retail price by calling 1-800-462-6420.
