**LeRoy Montoya,** 59, Clarksdale, Mo., died April 2 at his home.

LeRoy was born Nov. 2, 1954, to Manuel and Magdalena (Pino) Montoya in Mountainair, N.M., and grew up on the family ranch in Moriarty, N.M.

He married Jennifer Waller Dec. 18, 1998. Leroy was a member of Oak Christian Church and a life member of the American Angus Association. He was also a professional cattle fitter and cowboy who loved collecting rocks, fossils, antiques and Indian artifacts.

In addition to his wife, LeRoy is survived by sons Manuel Montoya and Jacob and Jeffrey Conley; brothers Facundo, Fred, Fidel and Michael Montoya and Casey Ingram; sisters Juana, Betty, Mary Ann and Lucy; and numerous nieces and nephews.

Forrest was born Oct. 27, 1916, in Barnard, Mo., to Emmet and Bertha (Giffin)



Byergo. He graduated from Guilford High School in 1934, and attended Northwest Missouri State College (now University) and the University of Missouri. He enlisted in the U.S. Navy in 1942 and served until

Forrest was a member of the Guilford United Methodist Church and taught high school Sunday School classes for many years.

In addition to his wife, Forrest is survived
