#### UBIA Bull Test Kenison Feedlot, Levan, Utah 84-day report (Jan. 12, 2016)

The Utah Beef Improvement Association (UBIA) received a total of 265 junior and senior bulls Oct. 5 at Kenison Farm and Feedlot, Levan. Bulls entered in the senior test must have been born Sept. 1-Dec. 31, 2014. Bulls entered in the junior test must have been born Jan. 1-March 15, 2015. 159 junior Angus bulls averaged 740 lb. going on test; 20 senior bulls averaged 890 lb. going on test.

Bulls are being fed by breed. Breeds that do not have adequate numbers to fill a pen (typically 50 head) were commingled with other breeds and are being fed together. There are two divisions within the junior Angus breed test. Those divisions are the traditional growth division and a low-birthweight (LBW) division.

# Tifton Bull Evaluation Program Tifton Bull Evaluation Center, Tifton, Ga. 84-day report (Jan. 12, 2016)

The 58th Tifton Bull Evaluation Program began Sept. 28 and 29, 2015, with the delivery of 190 bulls representing nine different breeds and averaging 787 lb. The 112-day test features bulls born Dec. 1, 2014-Feb. 28, 2015. All bulls tested negative for persistent infection with bovine viral diarrhea (PI-BVD).

#### 84-day report (Jan. 2, 2016)

# Southern Illinois University (SIU) Bull Test Carbondale, Ill.

56-day report (Jan. 5, 2016)

Southern Illinois University (SIU) accepted 40 bulls for testing Oct. 8-9, 2015, most of them junior bulls, for the 39th annual bull test for 2015-2016. Applications were due Sept. 8, with bulls tested in junior and senior divisions for 84 days this year. The test began Nov. 9-10, 2015.

The bull test station team is student-run this year, with Rebecca Atkinson, associate professor of animal science, food and nutrition for beef cattle providing advisory oversight and hands-on training. The objective is to test the bulls' potential for producing superior calves that will grow fast and efficiently. To be eligible for the program, bulls must be registered with a recognized national breed association, come to the facility in good health and meet other criteria set by Atkinson and the bull test station advisory board.

The student team will have the opportunity to learn to handle large livestock and assess animal health. Each bull is fitted with a magnetic collar that, when in close proximity to its assigned feed stall, unlocks the door. This helps the team ensure that each bull receives only its measured portion of grain. In addition, the student team will learn to conduct the ultrasonic tests and to conduct the scheduled weigh-ins.

The team, along with Atkinson, includes Claire Hoffman (McHenry), an animal science major; Alissa Hoyt (Carrollton), an animal science major; Alexis Johnson (Springfield, Tenn.), an animal science major; and Megan Tockstein (Odin), an animal science/ preveterinary medicine major.

University of Wisconsin, Platteville, Wis. 35-day report (Jan. 5, 2016) The Wisconsin Beef Improvement Association (WBIA) has conducted and overseen a central performance bull test each year since 1957. Young beef bulls from all over Wisconsin and the Midwest have been delivered to the University of Wisconsin– Platteville Farm to develop a performance proof in an unbiased environment designed to let the cream rise to the top. More than 5,000 bulls from more than 250 consignors have been tested.

A total of 103 bulls, 70 of them Angus, were delivered Nov. 2, 2015, for the 2016 WBIA Bull Test to go on test Dec. 1. The 100day test is for bulls born Jan. 1-April 15, 2015.

Bulls are fed a soy- or oat-hull-based ration adjusted with locally available ingredients in a ration designed to promote lean, efficient growth while providing adequate energy to allow individuals to express their genetic potential. At the test's conclusion, bulls are ultrasound scanned for carcass traits and evaluated for breeding soundness.

The 2015 Edisto Forage Bull Test (EFBT) began Dec. 15 in Blackville after the delivery of 61 bulls Dec. 1. Nominations were due Oct. 15, 2015. Senior bulls eligible for the test were born Nov. 1, 2014-Jan. 31, 2015. Junior bulls eligible for the test were born Feb. 1-March 31, 2015.

The test is located at the Edisto Research & Education Center near Blackville, S.C., and offers a unique approach to gain-testing bulls. It is a 168-day pasture-based test. EFBT was developed, built and started in 1982 with the commercial cow-calf producer in mind and capitalizing on the Southeast's advantage in the cattle business — the ability to grow high-quality, lush forages year-round. EFBT was designed to performance-test bulls in an environment in

which bull buyers expect their progeny to perform.

# Tucumcari Bull Test Tucumcari, N.M. 60-day report (Dec. 18, 2015)

There have been significant changes to the 2015-2016 Tucumcari Bull Test. The addition of GrowSafe® feed intake technology has allowed the measurement of feed intake per individual bull. This equipment also assists in calculating residual feed intake (RFI) efficiency for this year's set of bulls. The structure of the test itself has changed due to the new technology. There are now three separate contemporary groups (A, B and C), vs. one complete test group as in years past.
