

Roll of Victory Show

North American International Livestock Exposition Super-Point ROV and National Angus Show

► Louisville, Ky. • Nov. 15-16 • Judges: Gary Dameron, Lexington, Ill., and Jeff Dameron, Normal, Ill.

Angus exhibitors from across the country led 219 entries at the North American International Livestock Exposition (NAILE) Super-Point Roll of Victory (ROV) and National Angus Show Nov. 15-16 in Louisville, Ky. Gary Dameron, Lexington, Ill., served as lead judge, with his son Jeff Dameron, Normal, Ill., as the associate judge. They evaluated 165 females, 51 bulls and three cow-calf pairs that competed for honors and ROV points.

QLC LaGrand Forum claimed grand champion bull honors after first winning junior champion. Quirk Land & Cattle Co., Hastings, Neb., and LaGrand Angus Ranch, Freeman, S.D., own the March 2003 son of G13 Structure.

CQS Bando Connection 5042 won reserve grand champion bull and senior champion

honors. DAB Angus, Bell Buckle, Tenn., and Callie Smith, Lebanon, Tenn., own the November 2002 son of BT Bando 196J.

McCurry Bros., Sedgwick, Kan., led the grand champion female. Tenroc Miss EXT 7453-B is a January 2003 daughter of GAR Precision 6769 and first won junior champion.

Justin Brosey, Hamilton, Ohio, showed the reserve grand champion female, SCC Queen Beyonce 3053. The May 2003 daughter of PVF New Horizon 001 first topped the intermediate division.

Kyle Anderson, Chrisman, Ill., showed the grand champion cow-calf pair. WCC Barbara M84 is a February 2002 daughter of Twin Valley Precision E161. A February 2004 heifer calf sired by Summitcrest High Prime 0H29 completed the winning duo.

Jeana Sankey, Council Grove, Kan., led PF 4100 Elise 2053 to reserve grand champion cow-calf pair honors. The January 2002 daughter of LF New Trend 4100 had an April 2004 heifer calf by Connealy Forefront at side.

The first-place get-of-sire and junior get-of-sire entries, both consisting of progeny of Leachman Saugahatchee 3000C, were exhibited by Champion Hill, Bidwell, Ohio, and Weaver Angus Farm, Peoria, Ill. Weaver also showed the first-place breeder's best six head.
