Hamilton Angus Farm, Ava, Ill., celebrated its 70th year of operation. The farm was established in 1938 by Archie Hamilton. As a youngster, Archie, assisted by his ag teacher, purchased his first Angus heifer from Kurt Byrd of Galatia, Ill.

Archie continued in the Angus business until he was called to serve in World War II from July of 1945 to January of 1947. After serving a year of duty in Germany with the 331st Military Police Unit, Archie purchased a foundation group of breeding age females from George Bond in Galatia. The farm is a diversified operation, including purebred livestock, grain, hayland and pasture.

As the popularity of the Angus breed progressed, Archie purchased foundation herd sires from top operations at the time in order to raise superior, functionally sound, performance-oriented cattle.

Archie has been a life member of the American Angus Association since 1948 and a member of the Illinois Angus Association and the Southwestern Illinois Angus Association. Hamilton Angus Farm is a member of the Wabash Valley Angus Association. He has consigned cattle to numerous local association sales and hosted production sales.

Archie and his wife, Eileen, have three sons, Kenny, Glenn and Don, who grew up showing Angus cattle in 4-H and continue to show today. Two grandsons, Doug and Dusty, and a granddaughter, Kim, showed in 4-H, FFA and Angus junior shows. The Hamiltons have two younger granddaughters, Kelly, 10, and Kayla, 5, who ensure there will be Hamiltons in the showring for some time to come.

## **IN PASSING**

Paul "Doc" Keesee, 96, Oklahoma City, Okla., died April 17 in Tulsa, Okla., following a fall and subsequent medical complications.

Doc was born Dec. 24, 1912, at home in rural Sasakwa, Okla. In 1917, the family moved to Pecan Grove north of Holdenville, Okla., then moved to California before returning to Pecan Grove, where Doc lived until leaving home for college.

Doc graduated from Pecan Grove Grammar School and

then from Holdenville High School in 1934. He graduated from Cameron College in 1936 where he played football and was president of the Student Senate.

He graduated from Oklahoma A&M [now Oklahoma State University (OSU)] in 1938 with a degree in animal husbandry. He belonged to Alpha Gamma Rho fraternity. After graduation from OSU, Doc taught vocational agriculture at Carter, Okla., and Sayre, Okla., for four years. He entered veterinary school in 1942 and graduated from Kansas State University (K-State), Manhattan, Kan., in 1946 with a doctor of veterinary medicine degree.

Doc met Louise Nance of Hollis, Okla., while they were attending Cameron College in Lawton, Okla. They were married Aug. 12, 1939. After graduation from veterinary school, the Keesees moved to Essar Ranch near San Antonio, Texas, where Doc became the ranch veterinarian. In 1948, Doc became ranch manager and partner at Essar. He was a pioneer in artificial insemination (AI) and sterility work with cattle. The Essar herd was sold to Sen. Robert Kerr and Dean McGee in late 1955.

Doc and his family moved with the herd of cattle and six ranch partners to Poteau, Okla., in 1956 to establish Kermac Angus Ranch. He served as ranch manager and later became a partner in the operation. They routinely managed 2,500 commercial cows and 1,500 registered Angus cows, making it the largest Angus ranch in the world at the time. After the death of Sen. Kerr in 1963, McGee and Doc brought their portion of the Angus herd to the McGee-Keesee Ranch west of Edmond, Okla., where they remained for

Doc was internationally known for his trips to Scotland to purchase Angus cattle and as a judge for international cattle

shows, including the Chicago International Livestock Show.

Doc and Louise have a ranch north of Holdenville and partnered with his son and daughter-in-law in K&K Cattle Co. Doc was involved in real estate, primarily ranch and farm property, for a number of years after retiring from ranching. In August 1995 he and Louise built a home in northwest Oklahoma City.

A life member of the American Angus Association since 1950, Doc was also a member of the Oklahoma Angus Association and served as president of the Oklahoma Cattlemen's Association and the Tri-State Angus Association. He was an inductee into the Oklahoma Angus Association Hall of Fame. Doc belonged to the OSU Posse Club, Rotary Club, Kerr Memorial Men's Breakfast Club and Church of the Servant Methodist Church.

Doc is survived by his wife; daughters Nancy and Janie; son Paul Jr.; seven grandchildren and five great-grandchildren.

Chace Montoya, 30, Vian, Colo., died June 25 at his home.

Chace was born Nov. 30, 1977, in LaJara, Colo., to Facundo and Leigh Montova. He graduated from Oklahoma State University with a degree in animal science, specializing in reproduction. He also graduated from an embryologist school located in Manhattan,

He was a member of the American Angus Association as a junior member and later as co-owner of Question Mark Angus. Chace was a lifelong owner of Angus, buying his first heifer at age 8 and then staying home from school to watch her calve. He had many fond memories of exhibiting livestock across the country.

Chace was actively involved in many aspects of the livestock industry and had recently been pursuing another avenue of the livestock business — taking care of the love of his life, "the mama cow." His reproduction business, Question Mark Genetics, was starting to flourish due to his quest for taking care of the mama cow. The business had grown to include the horse industry this past year.

Chace is survived by his parents; daughter Tristyn, brother Britt and grandmother Mae. **Iola** (Vaughn) **Schaumburg,** 76, died July 16 at Wesley Hospital in Wichita, Kan.

Iola was born Jan. 17, 1932, at Maize, Kan., and graduated from Halstead High School in 1950. She was a nurse's aide at Halstead Hospital and served 17 years as a nursing assistant to Dr. Ruth Montgomery Short in Halstead. She served Memorial Hospital in McPherson, Kan., as director of volunteers for five years, retiring in 1982.

Iola was married to William Considine and had four children from that union. She later married Ronald Schaumburg. They were married for 25 years.

Iola is survived by her husband; sons Michael and Philip; daughters Mary Ann and Pamela; brothers Carl, Roy and James; stepdaughter Deborah; stepson Stephen; nine grandchildren and eight great-grandchildren.
