Champions Named at American Royal

Angus enthusiasts gathered Oct. 22 for the 2007 American Royal Super-Point Roll of Victory (ROV) Angus Show in Kansas City, Mo. Chuck Brost, Lexington, Ky., evaluated the 133 entries, which included 103 females, 27 bulls and three cow-calf pairs.

G13 Stand Out claimed grand champion and senior champion bull honors. Snake Creek Angus Ranch, Scottsbluff, Neb.; Greg Smith, Elida, N.M.; and Cherry Knoll Farm Inc., West Grove, Pa., own the January 2005 son of G13 Structure.

Jake and Kami Scott and Whitestone-Krebs, both of Gordon, Neb.; and Turner Farms, Satin, Texas, led the reserve grand champion bull. EXG First Degree is a January

2006 son of EXAR New Look 2971. He first topped the junior division.

SCC Echo Dell Nellie 6005 won grand champion female for Vince Untied, Granville, Ohio. The March 2006 daughter of PVF New Horizon 001 first topped the junior division.

PVF SCC Proven Queen 684 claimed reserve grand champion female for Taylor Adcock, Moweaqua, Ill. The May 2006 daughter of PVF New Horizon 001 first won intermediate champion.

Brody Fitzgerald and Cherry Knoll Farm Inc., both of West Grove, Pa.; and Katrina Frey, Quarryville, Pa., showed the grand champion cow-calf pair. Frey's Arkpride of Cherryknol is a February 2005 daughter of

CF Right Design 1802. A March 2007 heifer calf sired by Connealy Danny Boy is at side.

Jake Cunningham, Sheridan, Ind., showed the reserve grand champion cow-calf pair. TFR Cami is an April 2005 daughter of Northern Express 0424. A May 2007 heifer calf sired by SAV Masterpiece 5289 completes the winning duo.

Smith claimed junior get-of-sire and get-of-sire honors with progeny of G13 Structure and best six head honors.

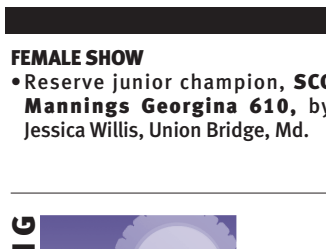

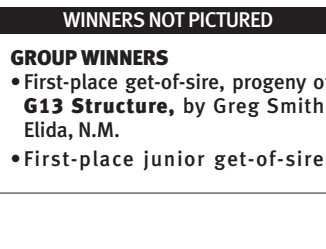

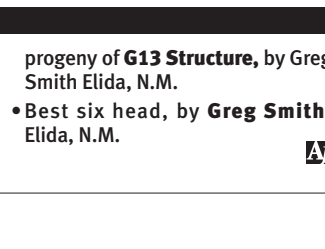
